BOOKING TERMS AND CONDITIONS

PRAXIS HOLIDAY LLP shall make every effort to make your journey comfortable and safe without any hitches to the extent possible. However we act as intermediary between the service providers ,airlines, hotels, transport operator and local tourist offices providing the services. **PRAXIS HOLIDAYS LLP** is therefore not responsible or for any loss, injury or damage sustained by the Pilgrim, including those occurring outside the touring programs. Additional expenses incurred by the delay, accident, natural disaster, political action and unrest must be borne by the tourists. Program, Prices, services and condition are based on those valid at the time of printing and are therefore subject to change without advance notice in the event of circumstances beyond our control.

PAYMENT :

1. All payments shall be made by Pilgrim favouring **PRAXIS HOLIDAYS LLP** by cheque or by NEFT/RTGS transfer to **PRAXIS HOLIDAYS ACCOUNT Current A/C 50200034095605, HDFC BANK LTD , EAST MAIN ROAD , ANNA NAGAR WESTERN EXTN , CHENNAI, 600101. IFSC CODE HDFC0001989**
2. **TOUR COST :** The tour cost payable by the Pilgrim is **INDIAN RS 1,75,000/- PLUS 5% GST.TOTAL INCLUDING GST RS 1,83,750/-**
3. Non refundable advance payment of **INDIAN RS 10,000** shall be made by the Pilgrim along with completed registration form and other undertakings. Payment inclusive of GST shall be **Rs 10,500/-**.

4. A further payment of INDIAN RS 80,000/- shall be made by the Pilgrim not later than 60 Days prior to date of departure(**11/07/2019**).**Payment including GST to be made is RS 84,000.**
5. Balance payment of INDIAN RS 85,000/- shall be made by thr Pilgrim not later than 30 days prior to date of departure(**11/08/2019**).payment including GST to be paid is Rs89,250

CANCELLATION AND REFUND:

1. Up to 30 days prior to date of departure Indian Rs 80,000 shall be the cancellation charges .
2. BETWEEN 29 DAYS AND 7 DAYS prior to date of departure the cancellation charges shall be 75% of the tour cost.
3. Cancellation within 7 days of departure shall be treated as NO SHOW and cancellation charges shall be 100% of tour cost .
4. GST once collected against each payment is NON REFUNDABLE.
5. Any refund amount due as per cancellation policy above shall be refunded to the Pilgrim in 15 working days from the date of cancellation.
6. All cancellation request shall be made by the Pilgrim in writing to PRAXIS HOLIDAYS LLP by letter or sent from registered email .PRAXIS HOLIDAYS will acknowledge promptly such request and advise the refund amount due and settlement date.

INCLUSIONS IN THE TOUR COST :

1. Lucknow to Lucknow all travel cost for 8 Nights/9Days as per itenary attached including surface travel between Luckow and Nepalgalganj by

Luxury BUS , 8 Nights hotel stay at Nepalganj(1N), Similkot (1N) Taklakot (1N), Darchen(1N) , Dirapuk (1 NIGHT), Zhutulpuh(1 N) , Taklakot (1 N) AND SIMILKOT (1 NIGHT).(SEE NOTE BELOW)*, All meal from lunch on day 1 to breakfast on Day 9 , flight between Nepalganj and Similkot, Helicopter travel between Similkot and Hilsa, Luxury bus travel from Hilsa-Taklakot-Mansarovar-Darchen- Yamadwar and return to Hilsa and finally return heli and flight to nepalganj and return to lucknow by car .

IMPORTANT NOTE

EVERY PAX WILL GET ONE NIGHT ACCOMODATION AT DARCHEN HIMALAYAN HOTEL PRIOR TO START OF PARIKRAMA. THOSE WHO OPT NOT TO GO FOR PARIKRAMA WILL GET ADDITIONAL TWO NIGHTS STAY AT DARCHEN HIMALAYAN HOTEL . PILGRIM WHO WILL UNDERTAKE 2 ½ DAYS PARIKRAMA WILL BE GIVEN ONE NIGHT STAY AT DIRAPUK DORMITORY WITH ALL MEAL AND ONE NIGHT AT ZHUTULPUK DORMITORY WITH ALL MEAL.ONCE A PILGRIM OPTS TO UNDERTAKE PARIKRAMA TIBET AUTHORITIES HAVE TO BE PAID FOR TWO NIGHTS ACCOMODATION AND FOOD AT DIRAPUK AND ZHUTULPUK.

PILGRIMS WHO WILL UNDERTAKE ONLY DAY 1 OF PARIKRAMA AND RETURN TO DARCHEN AFTER STAYING ONE NIGHT IN DIRAPUK WILL BE GIVEN ONE NIGHT ACCOMODATION AT DARCHEN HIMALAYAN HOTEL WITH ALL MEAL AT AN EXTRA COST OF RS 4000 PER PAX ON TWIN SHARING BASIS. THIS AMOUNT WILL BE COLLECTED FROM THE PAX BY THE TOUR MANAGER) . THOSE WHO DECIDE NOT TO UNDERTAKE PARIKRAMA AND STAY BACK IN DARCHEN HIMALAYAN HOTEL FOR NEXT TWO NIGHTS WILL PAY NO EXTRA COST .

3. Hotels:

Nepalgunj: Soaltee Westend Premier or Central Plaza twin sharing basis

Taklakot: Himalayan or Similar twin sharing basis

Darchen : Himalayan or Similar on twin sharing basis.

Similkot: Dormitory Guest House 5-6 Pax sharing

4. Duffle bag , backpack and mask shall be provided to Pilgrim on non returnable basis

5. Winter water proof down jacket shall be provided to Pilgrim on returnable basis

6. FIRST AID KIT – ALSO INCLUDED

First aid kit (typical backpacking kit for minor injuries/ our guide carry)-
Diamox/Aspirin/pain killers | |Lip guard, Vaseline | |Plasters, TCP, Vicks for sore throats

EXCLUSIONS IN THE TOUR COST:

1. High altitude travel insurance: PRAXIS HOLIDAYS will provide the Pilgrim Travel Insurance from TRAVEL TAG and the Pilgrim will pay the premium as given by Trawell Tag however manage any claim directly with insurance company. Cost of travel insurance will depend on age of Pilgrim however it is estimated to be Rs 1800- 3000 per pax.

2. Parikrama can be undertaken only on Ponny and hiring of Ponny for Parikrama is estimated to cost Chinese Yuan 3360 per Pilgrim and shall be directly paid by Pilgrim to ponny provider . Pilgrim shall carry required Yuan with him/her towards ponny charges however undertaking parikrama will

be decided solely by Sherpa leading the team depending upon the health and tolerance level of the Pilgrim.

3. The tour cost provides for only 8N/9D stay and one night complementary stay at Lucknow on 04th September 2019 .However beyond the reasonable control of Tour Operator for any unforeseen and force majeure situations like weather , Chinese Govt decisions , flight/heli cancellations , if tour gets extended then for each extra day Rs 4000 per Pilgrim shall be payable by the Pilgrim to the tour manager on demand during the tour.
4. Cost of emergency evacuation in the event of serious health condition, injuries, disability , death suffered by the Pilgrim during the tour.

ADDITIONAL TERMS AND CONDITIONS

1. There will be no compensation or refund to the Pilgrim for the un-used services .
2. If any Pilgrim returns without completing the tour due sickness or any reason whatsoever, cost of transportation from tour cancelling point to Lucknow will be borne by the Pilgrim.
3. Accommodation in the hotel will be provided on twin sharing basis at Nepalgunj, Taklakot and Darchen. In similkot , Dirapuk and Zhutulpuk it will be dormitory guest houses . It is possible that due to weather conditions Pilgrim may get held up at Hilsa and in such situation Praxis Holidays and Its Service providers will make best efforts to provide reasonable accommodation and food at these locations to Pilgrim.
4. If tour is cut short in Tibet due to bad weather or any unforeseen reasons whatsoever and group returns to Lucknow prior to the original schedule, then there will be no refund to Pilgrim towards services which remains unavailed in Tibet and Nepal.

5. If a part of group of wishes to return to Lucknow earlier than the rest, any additional cost involved in the transportation, accommodation, immigration penalty fee, visa fee etc applicable to clients and accompanying staff will be borne by such group.
6. In the event of lands slide, road blockage due to natural political or any reason whatsoever, Pilgrim will bear the extra cost of transportation and porters if required to reach the destination. It may be collected in advance before the tour start or on the spot depending in the situation.
7. Decision on any issues will normally be taken as per the wish of majority but final decision will taken by the tour leader in the best interest of all concerned.
8. All the arrangements within Tibet are solely at the discretion of TIBET AUTONOMOUS REGION FOREIGN EXCHANGE CENTRE .

RISK AND LIABILITIES

1. Any unforeseen cost increase beyond our control will be passed on directly to the Pilgrim whenever such increase are effected. This could include such items as airfare, visa fee, government taxes etc.
2. All baggage and personal effects are at all times at the Pilgrim's risk.
3. Chinese authorities reserve the right to:
 - A. Change the itinerary due to the reason beyond our control.
 - B. Alter the length of the itinerary if necessary.
 - C. Increase the cost as a result of change of itinerary.

In all these cases resulting increase in cost of tour shall be born by the PAX.
